

**Frequently asked Questions (FAQs) on Vacancy Notice No.MRVC/E/2018/1/PE
for engagement of Contract Project Engineers based on GATE Score 2018**

Sr.No.	Point of Doubt	Clarification
1	How to apply?	<ul style="list-style-type: none"> • The "On-line application form" along with "Vacancy Notice" is available on MRVC website under the tab "News & Information >> Vacancy Notices " . • In the Vacancy Notification under the heading "How to Apply" the procedure has been indicated step-wise for information of candidates.
2	Whether final year candidates can also apply?	<ul style="list-style-type: none"> • Final year candidates can also apply with mark-sheet & percentage of 7th Semester along with all other documents mentioned in the Vacancy Notice. • Such candidates, if shortlisted for document verification, have to produce the final year Mark list and Certificate at the time of document verification. However, if final result is still awaited, such candidates will have to produce the Mark list and Certificate by 30th September 2018 certain.
3	What if the candidate is getting 'error' while clicking on 'Next Step' or 'Final Submit' button ?	There might be some server error OR loading issues in website. So, wait for some time and try to reload the page.
4	Can the candidates keep the column of "Last name" blank ?	If there is no "Last name", the candidates can repeat their First name in the "Last name" field.
5	Do the candidates need to send the hard copy of the application ?	Applications received 'On-line' will only be considered. Candidates shortlisted for document verification have to bring the print out of the On-line application along with all documents mentioned in the Vacancy Notice.
6	Can a candidate of Instrumentation Engineering apply ?	Candidates of Civil/Electrical/Electronics & Telecommunication Engineering can only apply.
7	Can a candidate having color blindness apply ?	Medical fitness certificate from registered medical practitioner is required.

8	What if the acknowledge of receipt of On-line application not received by the candidate?	<ul style="list-style-type: none"> • On clicking "Final Submit" button, an automatic confirmation mail along with Application Number will be generated and sent to the entered email ID of the candidate. • If confirmation mail with Application Number is not received, the candidate should wait for some more time and if still it is not received, the candidate should reapply till receipt of confirmation mail. <p><i>Please note that the confirmation mail is an acknowledgement of receipt of application. The candidature will be considered only after scrutiny of application & documents, if found in order.</i></p>
9	Is NOC required from the current employer?	Candidates employed with Government Departments / PSUs / Autonomous Bodies even if on contract basis have to produce NOC at the time of document verification, failing which they would not be allowed to appear for document verification.
10	What is the nature of appointment?	The appointment is purely on contract basis as detailed in the Vacancy Notice under the heading "Nature of Appointment".
11	What are the admissible emoluments?	The details of emoluments are available in the Vacancy Notice.
12	How can the candidates check their Results?	The cut-off list of shortlisted candidates will be published on the website of the Corporation. Also the shortlisted candidates will be sent mail regarding the further procedure of engagement on the email ID mentioned in their application form.
13	How to raise to query, if any ?	In case of any query, candidates may contact this office through email "hrmrvvc@mrvvc.gov.in", quoting their Application Reference number. Queries will not be entertained through other means.
