The retention money shall be recovered from on account bills at rate of 10% of bill amount till the full Security Deposit of Rs. 2, 20, 12,480/-is recovered.

In terms of Special Condition of Contract you shall furnish the Performance Security of Rs. 2,20,12,480/- before signing of Contract Agreement. The Performance Security should be initially valid upto the stipulated date of completion plus 28 days beyond that. In terms of Special Condition of Contracts you shall submit the Performance Security within 28 days from the date of issue of Letter of Acceptance (LOA) .

You have to abide by the Contract Labour (Regulation and Abolition Act 1970) and rules, regulation and amendments there to that may be followed from time to time are binding on you in respect of this contract. You have to submit the application in the prescribed **form (Form -V) in triplicate for license under Contract Labour (Regulation and Abolition) Act for 20 or more workers and under BOCW Act for less than 20 Workers** together with the demand draft towards security deposit and license fee to the concerned Licensing Officer for the issue of the license irrespective of the number of labour employed for the work. The work should not be executed without a valid labour license.


You have to submit the evidence of insurance within 14 days of issue of LOA, and relevant policies within 28 days of issue of LOA as per relevant GCC and SCC clause.

Failure to start the work within seven days, the contractor is liable for penal action as per clause of the General conditions of contract.

**You should ensure that you are GST compliant and your quoted tax structure/rates are as per GST Law.**

The Completion period of the work is 12 months from the date of issue of Letter of Acceptance.
