The Government of India *has applied for* financing from the Asian Infrastructure Investment Bank (AIIB) towards the cost of the Mumbai Urban Transport Project - III A and intends to apply part of the proceeds toward payments under the contract for Design ,Manufacture, testing, supply, commissioning of machine, plants & equipments for Traction distribution maintenance
2. Mumbai Railway Vikas Corporation (MRVC) Ltd. now invites sealed bids from eligible bidders for;  
Design ,Manufacture, testing, supply & commissioning of WAGON MOUNTED STRINGING VEHICLE FOR UN-ROLLING /RE-ROLLING OF CONTACT & CATENARY WIRE ON CENTRAL RAILWAY ,as per specification no. No. MRVC.SPEC.M&P. STRINGING VEHICLE.2025, Sketch no. MRVC.Sk.M&P.SV.01 – 1 Nos.
3. Suppliers responsibilities have been embodied in the Bid documents.
4. Mumbai Railway Vikas Corporation (MRVC) Ltd. *an implementing agency* now invites online bids from eligible bidders for above items with stipulated completion period of the work 12 months as detailed in the Table below. Bidders are advised to note the clauses on eligibility (Section I Clause 4) and minimum qualification criteria (Section III – Evaluation and Qualification Criteria), to qualify for the award of the contract. In addition, please refer to paragraphs 4.4 of the “Interim Operational Directive on Procurement Instructions for Recipients” setting forth Asian Infrastructure Investment Bank’s policy on conflict of interest.
5. Bidding will be conducted through National Open Competitive Tender (NoCT) using Request for Bids (RFB) as specified in the Asian Infrastructure Investment Bank’s “Procurement Policy of January 2016 “ and Interim Operational Directive on Procurement Instructions for Recipients”, June 2016, and is open to all eligible Bidders.
6. Interested eligible Bidders may obtain further information from Chief Manager (Project-Electrical), Mumbai Railway Vikas Corporation Ltd. (E-mail:- [cmelectrical@mrvc.gov.in](mailto:cmelectrical@mrvc.gov.in) ) and inspect the Bidding document during office hours from 10:00 to 17:00 hrs. at the address given below.
7. Bidding documents in English are available online on <https://eprocure.gov.in> from **13.08.2025** to **16.09.2025** upto 15:00 hrs. Bidders will be required to register in the website. The bidders would be responsible for ensuring that any addenda available on the website is also downloaded and

incorporated. Bid document is also available for information on official website of MRVC [www.mrvcl.co.in](http://www.mrvcl.co.in). However, bidder has to submit the offer only on e-procurement website "<https://eprocure.gov.in>."

8. For submission of the bids, the bidder is required to have Digital Signature Certificate (DSC) from one of the authorized Certifying Authorities, authorized by Government of India for issuing DSC. Bidders can see the list of licensed CA's from the link ([www.cca.gov.in](http://www.cca.gov.in)). Aspiring bidders who have not obtained the user ID and password for participating in e-procurement in this Project, may obtain the same from the website: <https://eprocure.gov.in> . A non-refundable fee is required to be paid as per extant orders. The method of payment will be demand draft/ cashier's certified cheque payable at Mumbai in favour of "Mumbai Railway Vikas Corporation Ltd." or direct deposit to MRVC Bank account number as mentioned below the Table-A Payment documents are to be submitted subsequently as per the specified procedure.
9. Bids must be submitted online on e-procurement website <https://eprocure.gov.in>. on or before 15:00 hrs. on 16/09.2025. Any bid or modifications to bid (including discount) received outside e-procurement system will not be considered. The electronic bidding system would not allow any late submission of bids. 'Technical Part' of the Bids will be publicly opened online on the same day in the presence of the bidders' designated representatives and anyone who choose to attend at the address below on 16/09.2025 at 15:30 hrs and this could also be viewed by the bidders online. The "Financial Part" shall remain unopened in the e-procurement system until the second public Bid opening for the financial part. In the event of the date specified for bid opening being declared as a closed holiday for the purchaser's office, the due date for opening of bids will be the following working day at the appointed time.
10. All bids must be accompanied by a *Bid Security of the amount specified for the works in the Table given below, drawn in favour of "Mumbai Railway Vikas Corporation Ltd."* Bid security will have to be in any one of the forms as specified in the bidding document and shall have to be valid for 90 days beyond the validity of the bid. (Original bid security in approved form shall be submitted as per the procedure described below).
11. The bidders are required to submit (a) original bid security in approved form; (b) original affidavit regarding correctness of information furnished & (c) Power of Attorney (POA) in favour of Authorised Signatory of the bidder, to Chief Manager (Project-Electrical), Mumbai Railway Vikas Corporation Ltd. , Ground Floor, New Annexure Building, Mumbai CSMT- 400 001, Maharashtra, India , either by registered post/speed post/courier or by hand in sealed cover, before the opening of the technical part of the Bid given above, failing which, such bids will be declared non-responsive and will not be opened. The employer, MRVC is not responsible for any delay in submission of the original document. Ensuring that these documents reach the concerned MRVC official in time, is sole responsibility of the bidder
12. No Pre-bid meeting will be held for this tender.
13. Other details can be seen in the bidding document. The Purchaser shall not be held liable for any delays due to system failure beyond its control. Even though the system will attempt to notify the bidders of any bid updates, the Purchaser shall not be liable for any information not received by the bidder. **13. Bid Security:**

- (1) (a) The tenderer shall be required to submit the Bid Security with the tender for the due performance with the stipulation to keep the offer open till such date as specified in the tender, under the conditions of tender. The Bid Security shall be as under:

Value of the Work	Bid Security
For works estimated to cost up to ₹ 1 crore	2% of the estimated cost of the work
For works estimated to cost more than ₹ 1 crore	₹ 2 lakh plus ½% (half percent) of the excess of the estimated cost of work beyond ₹ 1 crore subject to a maximum of ₹ 1 crore

Note: The Bid Security shall be rounded off to the nearest ₹100. This Bid Security shall be applicable for all modes of tendering.
